#### II- REGISTRATIONS FOR PRESENTATION OF PAPERS

- **7.** All papers must be submitted via the website: **diprbrasil.com.br** Submission period: April 26 (from 8 am) to May 16 (until 6 pm).
- **8.** Those interested in presenting at the conference should fall within the following categories:
- Junior Researcher: undergraduate and Graduate Law students
- -O Researcher: candidates and graduates in Law at a Master's level, as well as PhD candidates in Law
- Senior Researcher: postgraduates with a PhD in Law
- **9.** Those interested should submit their papers in accordance with the requirements laid out in the Appendix and classify the theme of their contribution according to the following areas:

- 10. Papers can be submitted in co-authorship (up to 3 authors). If selected, only one speaker will present it.
- **11.** The submitted papers will be analyzed through a blind review system by at least two reviewers appointed by the Executive Committee, subject to the eligibility criteria.
- **12.** Reviewers may approve or reject the submitted article. If rejected, the author will need to resend their paper with amendments within 5 days.
- **13.** Non-compliance with the requested amendments within the deadline will result in the annulment of the registration.
- **14.** The Executive Committee is responsible for organizing the presentations of the approved papers according to their themes and qualification of authors.

#### III- REGISTRATIONS FOR PRESENTATIONS OF BOOKS

- **15.** All books must be submitted via the website: **diprbrasil.com.br** Submission period: April 26 (from 8 am) to May 16 (until 6 pm).
- **16.** All authors of monographic works on Private International Law or related areas, published in Brazil or abroad in 2017, 2018, 2019, 2020 and 2021, are eligible to register for the book session.

- **20.** The submitted books will be analyzed through a *double-blind review system* subject to the eligibility criteria by a reviewer with PhD appointed by the Executive Committee.
- **21.** The reviewer **is not allowed** to write a book review to be published in the e-book.
- **22.** The Executive Committee is responsible for organizing the presentations of the selected books according to the classification of their themes.
- **23.** A professor or a legal expert journalist will be appointed as a debate moderator.

#### RULES FOR SUBMISSION OF PAPERS (SELECTED ONES WILL INTEGRATE THE CONFERENCE E-BOOK)

- 1. Maximum length: up to 3,500 words (including footnotes);
- 2. DO NOT INDICATE author's name or affiliation this data will be collected on the registration form, but CANNOT BE REPORTED ON THE PAPER, UNDER PENALTY OF DISQUALIFICATION;
- **3.** Word format, Times New Roman 12, line spacing 1.5;
- 4. Footnotes in Word format, Times New Roman 10, simple spacing, numbered list;
- **5.** The text must be divided into topics (1., 2., 3.) and, if necessary, into subtopics (1.1., 1.2., 1.3.);
- **6.** If a new session division is necessary, it must be organized in subparagraphs (a), (b), (c);
- **7.** Citations and footnotes must be in conformity with the following requirements:
- **Book:** author's name (PEREIRA, Caio Mário da Silva). *full title of the book (in italics)*. Edition number (other than the first), Location: Publisher name, year of publication.
- **Book Chapter:** author's name (PEREIRA, Caio Mário da Silva). Full title of the article (no highlight). In: book author or editor's name (MONTEIRO, Washington de Barros) (Coord.). *full title of the book (in italics*). Edition number (other than the first), Location: Publisher name, year of publication.
- **Journal Paper:** author's name (PEREIRA, Caio Mário da Silva). title of the article (no highlights except for foreign words). *Name of journal (italics)*, volume number, pages (first and last pages), date of publication.
- -O Internet Resources: author's name (PEREIRA, Caio Mário da Silva), title, full website address (URL), date of reading.
